

OFFICIAL RULES — GOLDEN PANTRY JOYRIDE GOLF CART GIVEAWAY
NO PURCHASE OR DOWNLOAD NECESSARY TO ENTER OR WIN. A PURCHASE OR
DOWNLOAD WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE
PROHIBITED BY LAW.

1. Sponsor

The "Golden Pantry Joyride" Sweepstakes (the "Sweepstakes") is sponsored by Golden Pantry Food Stores, Inc., 1725 Electric Ave. Watkinsville, GA 30677 ("Sponsor").

2. Sweepstakes Period

The Sweepstakes begins at 12:00:00 AM ET on August 15, 2026, and ends at 11:59:59 PM ET on November 1, 2026 (the "Entry Period"). Entries received before or after the Entry Period will not be eligible. The official drawing for a potential winner will occur on November 9, 2026.

3. Eligibility

Open only to legal residents of Georgia who are at least 18 years old at the time of entry. Employees, officers and directors of Sponsor and its affiliates, subsidiaries, advertising and promotion agencies, prize suppliers, and any other entity involved in the development, administration, promotion or fulfillment of the Sweepstakes, including the immediate family members of each are not eligible. Immediate family members include spouses, parents, siblings and their spouses, children and their spouses and household members of each. Sweepstakes are void and prohibited by law.

4. How to Enter — Two Ways to Enter, Free of Charge

Method 1 — Golden Pantry Rewards App: Download the free Golden Pantry Rewards app, create an account, and enter through the "Joyride" promotion tab during the Entry Period. Standard data rates from your mobile carrier may apply; the app itself is free to download and use.

Method 2 — No-App Alternate Method of Entry (AMOE): Entrants who do not wish to use the app may enter by completing an online form including their full name, phone number, and email address. No purchase is necessary for entry.

Limit: One (1) entry per person, regardless of entry method, for the entire Entry Period, regardless of the number of app accounts or online forms submitted. Both entry methods will be entered into the same random drawing pool and have equal odds of winning.

5. Prize

One (1) winner will receive: **one (1)** customized golf cart, approximate retail value ("ARV") of \$11,000. Actual value may vary based on market conditions at time of award. The prize does not include delivery setup beyond [specify], registration/titling fees (if applicable), insurance, or any other expense not specifically stated. No cash substitution will be made, except Sponsor reserves the right to substitute a prize of equal or greater value if the stated prize becomes unavailable. Prize is non-transferable.

6. Winner Selection and Odds

One winner will be selected in a random drawing from among all eligible entries received through all methods of entry that meet the above-described Entry Period requirements. All eligible entries, regardless of method of entry, will be combined into a single electronic

database before the drawing. The random drawing will be conducted using a computerized random-selection process by Golden Pantry Food Stores or Golden Pantry Food Stores' designated independent representative, whose decisions are final. The drawing will take place on or about November 9, 2026. Odds of winning depend on the total number of eligible entries received.

7. Winner Notification

Sponsor will attempt to contact and notify the selected winner by phone, email, or app notification using the contact information provided in connection with the eligible entry, within two business days of the drawing. The selected winner will be required to sign and return an Affidavit of Eligibility, Liability Release, and (where legal) a Publicity Release within seven (7) days of notification. If a selected winner cannot be reached, fails to respond within the required time, or is found ineligible, Sponsor reserves the right to disqualify that entrant and select an alternate winner.

8. Taxes

The winner is solely responsible for all applicable federal, state, and local taxes associated with acceptance and use of the prize.

9. General Conditions

By entering, participants agree to be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all respects. Sponsor reserves the right to cancel, suspend, or modify the Sweepstakes if fraud, technical failures, or any other factor beyond Sponsor's control impairs the integrity of the promotion. Use of any automated system, script, macro, bot or other device to enter is prohibited and will result in disqualification. Sponsor reserves the right to disqualify any entrant who attempts to tamper with the entry process, circumvent these Official Rules, submit entries using multiple identities or accounts, or otherwise interfere with the proper administration of the Sweepstakes.

Sponsor makes no representation or warranty concerning the prize and disclaims all warranties, express or implied, except to the extent any manufacturer's warranty may apply.
